
Performance Review

The Saudi Stock Market Index (TASI) achieved positive returns to close by the end of the this month at 7,628.34 with a decrease of 618.25 points over the close of the previous month. The total value of shares traded over the month reached SAR 71.60 billion, decreasing by 15.14% over the previous month. The main sectors that achieved the highest positive performance were Software & Services 23.87% and Pharma, Biotech & Life Science 2.75%. On the other hand, Telecommunication services and Utilities Sectors declined by -16.55% and -15.36%, respectively.


